Special Presentation to Former Fire Chief Foster Grimes

Mayor and Commission presented Foster Grimes with a plaque honoring his service as Fire Chief.

Presentation from Police Chief Kevin Jarriel

Chief Jarriel reviewed the monthly activity report with the Commission. Jarriel also reviewed a memo detailing a new rank and pay scale for the TCPD.

Discussion of Twin City Police Department Vehicle Purchase

Chief Jarriel reviewed his purchase recommendation with the City Commission. After reviewing multiple bids and options, Jarriel recommends purchasing the vehicle from Metter Ford and outfit the vehicle separately. The City Commission agreed to a budget of up to \$56,000.00 for the vehicle and equipment. The City will surplus the Ford Explorer and sell separately.

Discussion of Intergovernmental Agreement with Emanuel County Board of Commissioners to hold 2025 Municipal Elections

The City Commission agreed for the Emanuel County Board of Elections to conduct the 2025 Municipal Elections.

Discussion of 2025 Resurfacing Project Planning and application to Georgia Transportation Infrastructure Bank (GTIB) for funding.

The total project includes (16) roads for an estimated budget of \$2,100,000.00. The City will be seeking a \$150,000.00 GTIB loan with a \$550,000.00 GTIB grant. The remaining funds will come from city sources.

Discussion of 2025 GDOT Local Maintenance Improvement Grant (LMIG) application in the amount of \$34,420.86 for resurfacing Ward Street

The City Commission agreed to submit Ward Street for 2025 LMIG funding.

Discussion of vacancy on the Planning Commission of the City of Twin City

Due to death of Planning Commissioner Dewayne Rollins, there is a vacancy on the Planning Commission. Mayor Donaldson asked the City Commission for suggestions on the replacement.
