#### **Presentation from Police Chief Hank Whiters**

Chief Whiters reviewed the monthly activity report with the Commission. Officer Dixon graduated from the Police Academy on September 23<sup>rd</sup>.

#### Discussion of Local Option Sales Tax (LOST) Certificate of Distribution

City of Twin City shall receive 7.21 % of the LOST distribution for the next 10 years.

#### Discussion of renewal of probation services agreement with Judicial Alternatives of Georgia

The Commission reviewed the contract renewal of probation services. Upon a recommendation of the Police Chief Whiters and Municipal Court Judge McNeely, the Commission agreed to continue with Judicial Alternatives of Georgia.

#### Discussion of 2023 Occupational Tax Certificate Schedule

The Commission reviewed the schedule with no changes recommended from the previous year.

# Discussion of Joint Comprehensive Plan and Community Work Program update for City of Twin City

Mayor Donaldson has worked with the Heart of Georgia Altamaha Regional Commission to update the city work plan. The Commission reviewed the plan and community work program with no changes.

## Discussion of 2022 Millage Rate

The Commission reviewed the 5-year tax digest history. Mayor Donaldson recommends the Commission adopt the roll-back rate of 6.619, which is a 2.89% reduction in property taxes. The millage rate will be formally adopted at the November meeting.
