Presentation from Police Chief Hank Whiters

Chief Whiters reviewed the monthly activity report with the Commission. Chief Whiters informed the City Commission that he has two cadets for Police Academy in July.

Discussion of SPLOST 7 (2024-2029) Projects

Mayor Donaldson presented the SPLOST 7 projects to the Commission. The projects are as follows: water & sewer system improvements, road improvements, police vehicles and equipment, fire department equipment, recreation improvements and equipment, sidewalk and trail improvements, public works equipment and debt service, and public building/facility improvements.

Discussion of Resolution 01-2022- ARPA Reporting

The Treasury Department allows non-entitlement units of local governments (NEUs) a standard allowance of up to \$10 million of revenue loss that can be used for government services regardless of their actual loss of revenue. This allowance gives the City Commission the greatest flexibility to allocate pandemic relief funds to necessary City projects, such as water and sewer infrastructure, road infrastructure, economic development, and revenue loss. The Commission agreed to accept the standard allowance for the ARPA reporting.

Discussion of J & T Environmental Contract revision

This item was tabled until the May 2022 meeting.

Discussion of Fire Department surplus request

Fire Chief Grimes would like to surplus the 1986 Chevrolet D30 Military VIN 1GCGD34J0GF366569 to the City of Garfield Volunteer Fire Department, which has been using the equipment for several years. The equipment was gifted to the City decades ago from the US military.

Discussion of Georgia Cities Week Resolution 02-2022- April 24-30, 2022

The City Wide Clean Up will be held on Saturday, April 30^{th} from 9:00AM - 2:00PM. There will be (3) dumpster locations throughout Twin City for household garbage only.

Discussion of GEFA Water Meter Replacement Project advertisement for bid

Turnipseed Engineers has prepared and posted the bid package for this project to replace all the water meters in the Twin City utility system. The bid opening will be held on Tuesday, April 19th at 2PM.

Discussion of closure of Twin City Health Department

Mayor Donaldson informed the Commission of the closure of the Twin City Health Department. The Commission agreed this was a vital community resource. Mayor Donaldson will be sending a letter to the local Health Department Board to request they reconsider the decision.
